Purpose of the ACSP Partnership Statement

The 2026 Partnership Statement is a formal agreement and strengthens collaboration between Lanarkshire Carers, University Health and Social Care North Lanarkshire, and South Lanarkshire University Health and Social Care. It updates the 2021 agreement, defines the roles of each partner and clarifies shared responsibilities for delivering ACSPs. It is a common reference point, useful guide and referral/signposting resource.

An ACSP is progressed through a conversation about the caring role that helps to identify the impact on carer wellbeing and life-balance, their personal outcomes/hopes, support needs and how these might be met.

LANARKSHIRE CARERS JOURNEY ROUTES



Lanarkshire Carers commissioned responsibilities include the lead responsibility for progressing ACSPs with carers with low to moderate needs.

Carer Support Workers are colocated in Social Work localities throughout Lanarkshire to help appropriate collaborative working. All carers can access information, advice and support from the Carers Centre.

Social Work has the lead responsibility for progressing ACSPs with carers with substantial or critical needs, including statutory support and Self-Directed Support discussions.

There is no requirement for carers to be signposted or referred to Lanarkshire Carers prior to having conversations with Social Work staff or receiving statutory support, as this may delay support for carers with substantial and critical needs.

South Lanarkshire applies a wellbeing risk framework for eligibility; North Lanarkshire uses a 'what would help' approach.

Adult Carer Support Plan delivery arrangements are embedded within local Carer Strategies.



Short Breaks Service Statements provide information about what services are available to give carers a break from their caring role.
